These risks include, but are not limited to: falls, burns, dehydration, exposure to the elements, drowning, insect and animal bites, human errors, equipment failure, and falling debris that may result in serious injury or even death. I understand these risks and agree to assume them.

I hereby release from any and all liability, for myself and my heirs, any and all members, participants, instructors, or organizers of events offered through SOLAR; SOLAR steering committee members; and the SOLAR organization itself for any harm or injury that I suffer as a result of my participation.

This release is to include any risk or harm listed above, as well as any and all risks, known or unknown, which I may encounter through my participation in the activities in which I may choose to engage.
